


Figure 1.10. Emerging Markets: Portfolio Flows and Asset Market Performance

The main differences between these two datasets include (1) fund flows data are sample-based and mainly capture retail investors, (2) different country samples, and (3) limited coverage of hard currency flows in the IIF data. AE = advanced economy; EM = emerging market; EMBIG = JP Morgan's Emerging Market Bond Index Global; ETF = exchange-traded funds.
