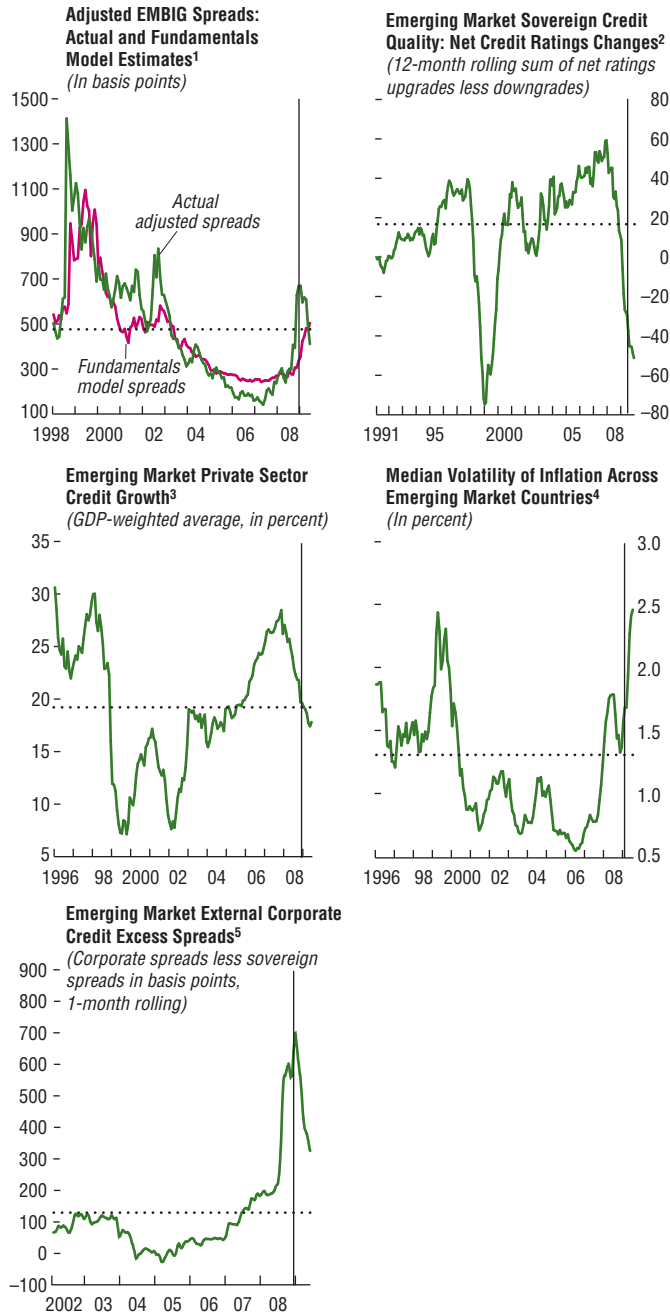


**Figure 1.37. Global Financial Stability Map:
