
Figure 2.13. Decomposing Lending Standards: Mortgage Loans

Economic outlook factors are the fitted values constructed using the responses to general economic activity and setting all other coefficients to zero. Analogously, balance sheet factors are the fitted values constructed using the responses to cost of funds.
