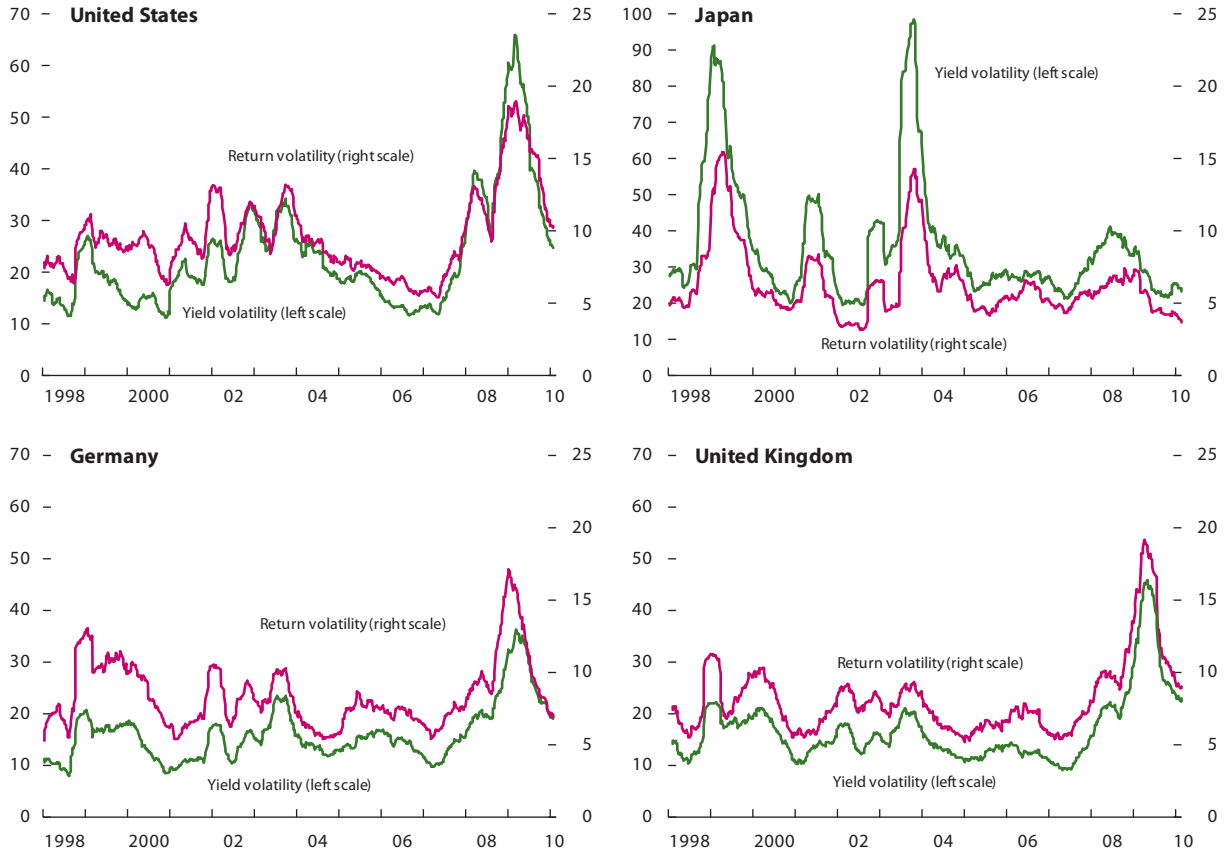


Figure 8. Historical Volatility of Government Bond Yields and Bond Returns for Selected Countries¹
