#### PLANS FOR PREPARATION AND FINALIZATION OF NEW MANUAL

- 1. This paper presents a proposal for a timetable for work on the revision of *BPM5* and is an update of the proposal in "Updating *BPM5*: A Proposed Timetable and Structure" (BOPCOM-02/26). The paper proposes that three technical expert groups be set up and the type of issues each will address based on the Annotated Outline.
- 2. The review of the *System of National Accounts (SNA)* will be conducted at the same time as the update of the *BPM5*. There will be continuing contact between the balance of payments community and the Intersecretariat Working Group on National Accounts (ISWGNA) and its Advisory Expert Group (AEG), which is being established to assist in the review of the *SNA*.
- 3. The proposed timetable in this paper to update *BPM5* has been designed to be compatible with the national accounts review process. The processes in 2004-2006 are similar, with the first draft of the revised balance of payments manual scheduled for late 2006, a few months after the completion of the draft national accounts revisions in mid-2006 so as to incorporate changes and cross-references in the draft balance of payments manual. There will be a presumption that the balance of payments and national accounts frameworks will be the same or compatible, so good communication with the ISWGNA and AEG will be necessary, and the new manual will take account of ISWGNA decisions, to the extent possible.
- 4. For some topics that are relevant to the balance of payments, there are already electronic discussion groups, task forces, and working groups that will also need to be considered (e.g., IMF-administered electronic discussion group on nonperforming loans, Canberra II group on nonfinancial assets).
- 5. In addition to the role of the IMF and the IMF Committee on Balance of Payments Statistics (the Committee), it is proposed that up to three technical expert groups (TEGs) will be established to assist in the research and resolution of more detailed issues and to undertake a general review of the draft of the manual:
  - direct investment (DITEG). There are a range of issues associated with direct investment. DITEG would be a joint group of OECD and IMF. The work of DITEG would be coordinated with the OECD revision of the *Benchmark Definition of* Foreign Direct Investment<sup>1</sup>;
  - currency union (CUTEG). The issues associated with currency unions are specialized and will be given increased priority in the new manual, so a group would assist in dealing with the issues; and

- other balance of payments issues (BOPTEG). This group will examine all other issues, such as arrears, residence, portfolio investment, and reserves.
- 6. Selection of TEG members would take account of topics identified by the 2003 Committee meeting. There would be a core group and possibly others added for a particular discussion because of their particular field or fields of expertise. Members would be chosen to have a range of experience and backgrounds in both specific and general issues while having a familiarity with the concepts and detailed practical knowledge of the issues and capable of making a sufficient commitment of time. TEG members, IMF staff, and others would provide discussion papers to the TEGs to assist in the deliberations, with options or recommendations to be tabled at subsequent Committee meeting. TEGs would work by email communication supplemented by occasional meetings.
- 7. The TEGs would disseminate their work on the internet and report to the Committee meeting.
- 8. During this process, there would be e-mail consultation with Committee members so that continuing work on the manual would not be held back by being limited to a single annual meeting by the Committee.

#### B. Issues Possibly Requiring Further Work

- 9. As a starting point, the following table sets out some of the main issues and possible timing and allocation of tasks. Agreement on some issues may be identified from the written comments on the Draft Annotated Outline or from discussions at the 2003 Committee meeting. In addition, issues where additional work is needed will be identified. The following is a preliminary list to help guide the identification of issues. Nevertheless, the identification of settled issues at this stage will not be final, so that some issues initially identified as settled may be reconsidered at a later stage.
- 10. The following is a list of issues that possibly will require further work, together with a possible forum and timing of discussion. The list will be winnowed after the 2003 Committee meeting. (A complete list of issues is shown at the end of each chapter of the Draft Annotated Outline.)
