
## Figure 5.8. Macroeconomic Indicators after Downturns, with and without a Fiscal Stimulus<sup>1</sup>

<sup>1</sup>Fiscal stimulus during the first year of a downturn is defined as a decline in the cyclically adjusted primary balance to GDP below 0.25 percentage point of GDP. <sup>2</sup>Exchange rate is given as local currency/U.S. dollar (+ sign denotes a depreciation).

Value for emerging economies with fiscal stimulus is -10.5; with fiscal tightening -21.2.
