
Figure 3.22. Sensitivity of Longer-Term Inflation Expectations to Changes in Oil Prices

Blue bars denote estimation results using survey-based inflation expectations: "Professional" denotes the results using 5-year-ahead inflation forecasts from Consensus Economics; while "Households" denotes results using inflation expectations (5–10 years) from the Michigan survey. Red bars denote results using market-based inflation expectations based on five year/five year inflation swaps. The effective lower bound (ELB) is defined as starting in 2009. The full sample refers to the period 2004–16.
