Context:

The International Monetary Fund (IMF) advises its Members States, including Mongolia, and supports the efforts of the authorities of the countries to implement policies aimed at strengthening their economic stability, reducing vulnerability to economic and financial crises, and improving the standard of living of their people.

The IMF is looking to hire for the office of its Resident Representation in Mongolia, an economist. The latter will oversee all tasks related to the functions and responsibilities described below:

Duties and Responsibilities:

Under the general authority and supervision of the Resident Representative, she/he will particularly:

- Develop, maintain, and update comprehensive databases on real, monetary, financial, and external sectors in liaison with the Bank of Mongolia (BOM), Financial Regulatory Commission (FRC), National Statistics Office (NSO):
- Participate in the HQ-led missions as well as collaborate and exchange information with BOM, FRC, NSO, and private sector representatives.
- Organize and participate in meetings related to her/his responsibilities.
- Perform analytical work, including undertaking economic analyses, assessing, monitoring, and analyzing economic developments, and programs and coordinating technical assistance (especially in the areas of real, monetary, financial, and external sectors).
- Research and prepare a variety of academic level outputs.
- Demonstrate creativity in the face of new problems and economic contexts.
- Collaborate with local stakeholders, including bilateral and multilateral donors/development partners.
- Keep the Resident Representative informed on local developments notably in real, monetary, financial, and external sectors.

The successful candidate will be expected to consistently demonstrate the ability to work independently and strengthen the IMF's relationship with the country of operation. They must be available (including when needed outside normal office hours), able to work under pressure in a multicultural environment, and demonstrate great organizational skills.

Skills and qualifications required:

- Completed Master's degree in Macroeconomics or have initiated a doctoral program. A completed PhD in Economics would be considered as a strong advantage.
- Five or more years of relevant work experience (Examples: operational knowledge of the central bank operation) or equivalent experience.
- Proficiency in Microsoft Office (particularly Word and Excel) and econometric software such as Stata, EViews.
- Advanced knowledge of statistical and econometric techniques and macroeconomic relationships.
- Publications of research papers in academic journals would be considered as an important advantage.
- Perfect command of English.
