

**IMF Primary Commodity Price Index**  
**(Base: 2016=100)**  
**Jan 25, 2019**

***Chapter 1: Introduction***

1.1 This technical note describes the calculation and composition of the revised IMF primary commodity price index (PCPI), as well as the data sources used.

The PCPI is a weighted average of select commodity price indices, based on identified benchmark prices which are representative of the global market. The weight is calculated based on the global import share over a 3-year period (2014-2016), and is normalized to 100 at year 2016 prices. It represents four broad commodity asset classes: (1) energy, (2) agriculture, (3) fertilizers, and (4) metals. The PCPI starts in January 1992, and is available in monthly, quarterly, and annual frequency. All benchmark prices are denominated in USD.

***Chapter 2: Calculation***

2.1 The PCPI is calculated as a weighted average of 68 commodity prices:

$$P_t = \sum_{k=1}^{68} p_t^k W_t^k$$

where  $p_t^k$  is the selected normalized price of commodity  $k$  at time  $t$  and  $W_t^k$  is the weight given to price  $p_t^k$ . Normalized prices are calculated by dividing the nominal commodity price by the base price, where the base price is taken to be the average price in 2016 for that commodity, so that the value of the normalized price and the PCPI equal 100 in 2016.

Weights are calculated as import weights, that is, the share of imports of commodity  $k$  in total global commodity imports:

$$W_t^k = \frac{V_t^k}{\sum_{k=1}^{68} V_t^k}$$

***Chapter 3: Index Composition***

3.1 The PCPI is composed of 68 commodities, of which 6 (oil, coal, gas, coffee, sugar and wool) are actually commodity ‘groups’ since they represent a weighted average of various

prices of the same commodity from different parts of the world.<sup>1</sup> All in all, the PCPI includes 68 individual commodities (Table 1).

3.1 The PCPI has several sub-indices, with several sub-components (Table 2). At the highest level, the PCPI is a weighted average of the Fuel (Energy) Index, the Agriculture Price Index, the Fertilizer Price Index, and the Metals Price Index.

***Chapter 4: Data Sources***

4.1 The benchmark prices are obtained from various sources at high frequency which are then converted to monthly frequency by averaging weekly or daily values (see Table 3). Quarterly and annual frequencies are averages of the monthly values.

4.2 The average value of global imports in 2014-2016 was used to construct the weights for each of the 66 commodities. As import and export trade data show discrepancies, imports are chosen because data is better; due to it being generated from levying of tariffs. Global imports for each commodity for the years 2014-2016 were obtained from UN COMTRADE. To guide the PCPI compilation, we used the 6-digit HS2012 classification. For each commodity group we selected all relevant 6-digit HS2012 codes -based on our expert judgement- and obtained global imports by summing up over all the relevant 6-digit categories. Our criteria for inclusion were:

- (i) a close fit between the product description of the HS code and the relevant commodity group, and
- (ii) the HS code describing a raw/primary or slightly processed product (thereby excluding fully processed or manufactured products).

In select cases, 6-digit HS2012 codes were assigned to a commodity group, and the global import trade value was then distributed amongst the individual commodities, based on their weight in the respective commodity group. For some broader commodity groups, for example “non-citrus fruit + orange juice” or “fish”, products were selected based on certain shared characteristics (close substitutes). Finally, the import share of each commodity group is then obtained by dividing world imports for that commodity by the total global import value for all commodities. Please see Table 4.
