TRANSPORT TO THE AIRPORT

The easiest and fastest transportation both from and to the airport is by regional train (NOK 118) or the airport express train (NOK 230)

The train station Nationaltheatret is about 10 minutes walking distance from Norad. Total travel time from Norad is 40 minutes in average (the airport express train a few minutes faster), with relatively frequent departure times.
