Global Consultation Comments:

The respondent who disagreed with the Proposed Recommendations noted that "it would be more useful if the upcoming manual contained more detailed information on this issue than the SNA 2025". This seems to in fact support the recommendation of developing a discussion note on the topic.

Of the two respondents that partially agreed, one suggested awaiting for the outcomes of research project 2.27 (Relationship between GFS and IPSAS), while the other respondent highlighted that research project focused more on IPSAS than IFRS.

• "We agree with the proposal but note that it appear to focus on IPSAS. In our experience, instances where public corporations are required to apply IFRS rather than IPSAS are not that rare globally, and this should be acknowledged in the GFSM."

Respondents that agreed with the Proposed Recommendations highlighted the importance of including guidance on the differences between GFS and IPSAS/IFRS, with one respondent suggesting the inclusion of bridge tables.

The relationship between GFS and International Public Sector Accounting Standards (IPSAS) will be researched through the GFSM Update research project 2.27 (*Relationship between GFS and IPSAS*). Within the same research project consideration will be given to highlighting key differences between IPSAS and the International Financial Reporting Standards (IFRS).¹
