PROCEDURAL BACKGROUND

1. On August 4, 2026, the Tribunal issued IMFAT Order No. 2026-2 on the admissibility of the three Joint Applications for Intervention (“JAFI”) filed pursuant to Rule XIV, Paragraph 1 of the Tribunal’s Rules of Procedure in the present case.¹ The Tribunal made the following Decision:

For the reasons set out above:

- a. The Joint Application for Intervention filed by Fund employees under an open-ended appointment in *J. Manning v. IMF* (referred to in the present Order as the JAFI Manning (open-ended)) is admitted except with respect to the employees whose application for intervention is identified as “not admissible” in Annex 1 to this Order.
- b. The Joint Application for Intervention filed by Fund employees under a fixed-term appointment in *J. Jara v. IMF* (referred to in the present Order as the JAFI Jara (fixed-term)) is admitted except with respect to employees whose application for intervention is identified as “not admissible” in Annex 2 to this Order.
- c. The Joint Application for Intervention filed by Fund contractual employees in *J. Jara v. IMF* (referred to in the present Order as the JAFI Jara (contractual)) is denied.
- d. The Prospective Intervenors’ Requests for Anonymity are denied.
- e. If, in light of the Tribunal’s decision on the Requests for Anonymity at paragraph 71(d) above, any Intervenor wishes to withdraw from the relevant Joint Application for Intervention, that Intervenor shall inform the Tribunal of his/her withdrawal by Tuesday, September 1, 2026 at the latest.

- f. The present Order shall be circulated within the Fund and published on the Tribunal's website without its Annexes 1, 2, and 3, which identify the 129 Prospective Intervenors.
- g. Any Intervenor who withdraws from the relevant Joint Application for Intervention in accordance with the procedure outlined at paragraph 71(e) above, shall remain anonymous.
- h. Any Intervenor who fails to inform the Tribunal of his/her withdrawal in accordance with the procedure outlined at paragraph 71(e) above, i.e., by Tuesday, September 1, 2026 at the latest, shall not have the benefit of anonymity if that Intervenor elects to withdraw from the relevant Joint Application for Intervention at a later date.
- i. The Fund employees whose application for intervention was denied shall remain anonymous.²

2. On August 31, 2026, Counsel for the Intervenors informed the Registry of the withdrawal of eighteen Intervenors: (i) Intervenors nos. 1, 18, 22, 34, 36, 39, 44, 48, 62, 64, 68, 73, 76, and 82 from the JAFI Manning (open-ended);³ and (ii) Intervenors nos. 1, 7, 8, and 9 from the JAFI Jara (fixed-term).⁴

CONSIDERATIONS ON THE WITHDRAWALS NOTIFIED BY INTERVENORS IN *J. MANNING V. IMF* AND *J. JARA V. IMF*

3. The Tribunal notes that the Applications for Intervention of Intervenors nos. 1, 34, 39, and 64 in *J. Manning v. IMF* and the Application for Intervention of Intervenor no. 8 in *J. Jara v IMF* were identified as “not admissible” in Annexes 1 and 2 to IMFAT Order No. 2026-2, respectively.⁵ The issue of withdrawal was therefore moot with respect to these five Intervenors.

4. The Tribunal otherwise notes that Intervenors nos. 18, 22, 36, 44, 48, 62, 68, 73, 76, and 82 have withdrawn from the JAFI Manning (open-ended) in accordance with the requirements set forth in paragraph 71(e) of IMFAT Order No. 2026-2, i.e., by notifying the Tribunal of their withdrawal prior to the Tuesday, September 1, 2026 deadline. Similarly, Intervenors nos. 1, 7, and 9 have withdrawn from the JAFI Jara (fixed-term) in accordance with these requirements. The revised versions of Annexes 1 and 2 to IMFAT Order No. 2026-2, which are appended to the present Order,

now contain an indication of whether the Intervenors have notified the Tribunal of their withdrawal from the relevant Application for Intervention, along with the date of such notification.

5. As per paragraph 71(g) and (i) of IMFAT Order No. 2026-2, all of the Intervenors listed in paragraph 2 above shall remain anonymous. Accordingly, all of these Intervenors have been referred to in the present Order by the number allocated to each of them in Annexes 1 and 2 to IMFAT Order No. 2026-2.⁶ In addition, the revised version of Annexes 1 and 2 will be published in redacted form with the present Order so as to maintain the anonymity of the Intervenors who have withdrawn from a Joint Application for Intervention.⁷

ORDER

6. In light of the above, the Tribunal unanimously decides to record that: (i) Intervenors nos. 18, 22, 36, 44, 48, 62, 68, 73, 76, and 82 have withdrawn from the JAFI Manning (open-ended) in accordance with the requirements set forth in paragraph 71(e) of IMFAT Order No. 2026-2; (ii) Intervenors nos. 1, 7, and 9 have withdrawn from the JAFI Jara (fixed-term) in accordance with these requirements; and (iii) the proceedings before the Tribunal have accordingly been terminated with respect to these Intervenors.
