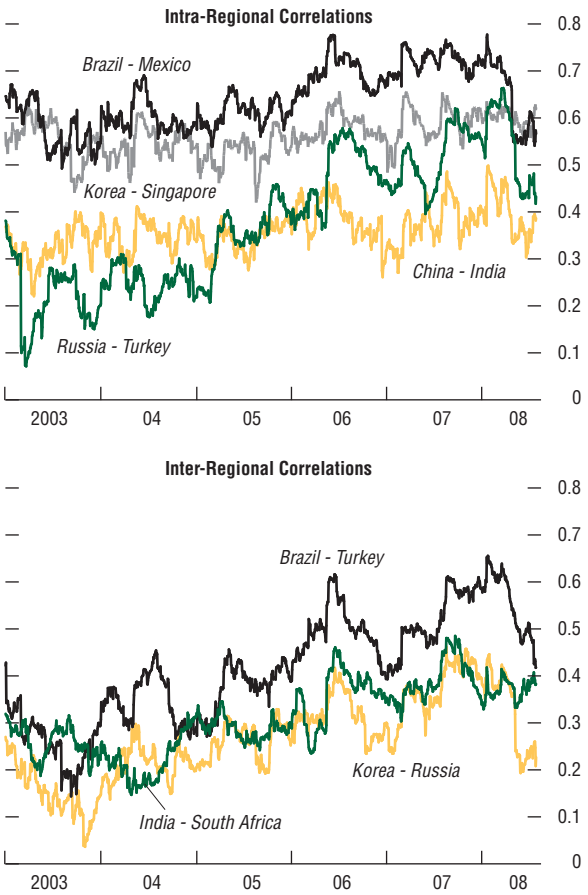


Figure 4.10. Emerging Market Countries: Implied Correlations from Dynamic Conditional Correlation GARCH Specification
