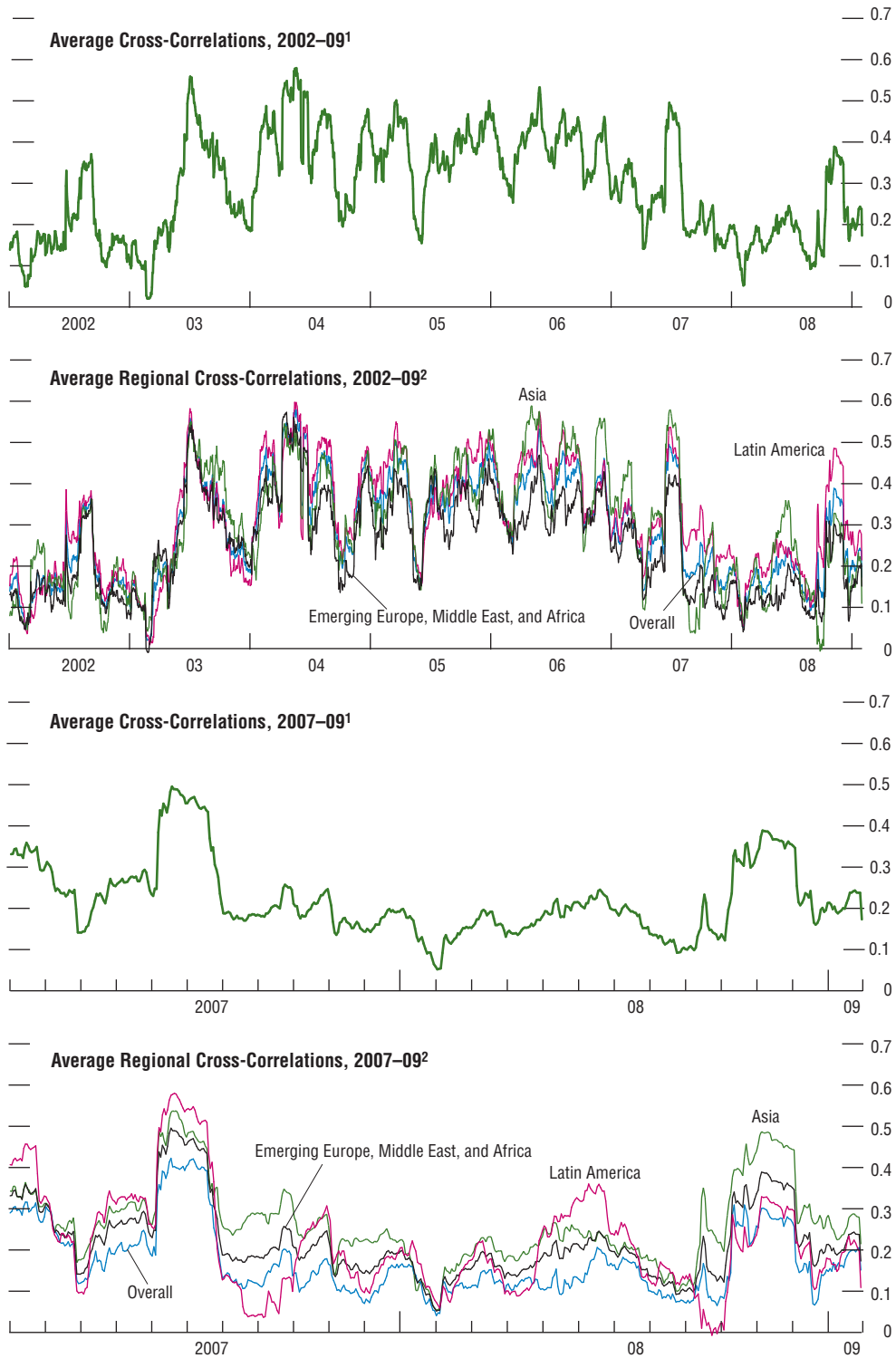


Figure 16. Emerging Market Debt Cross-Correlation Measures
