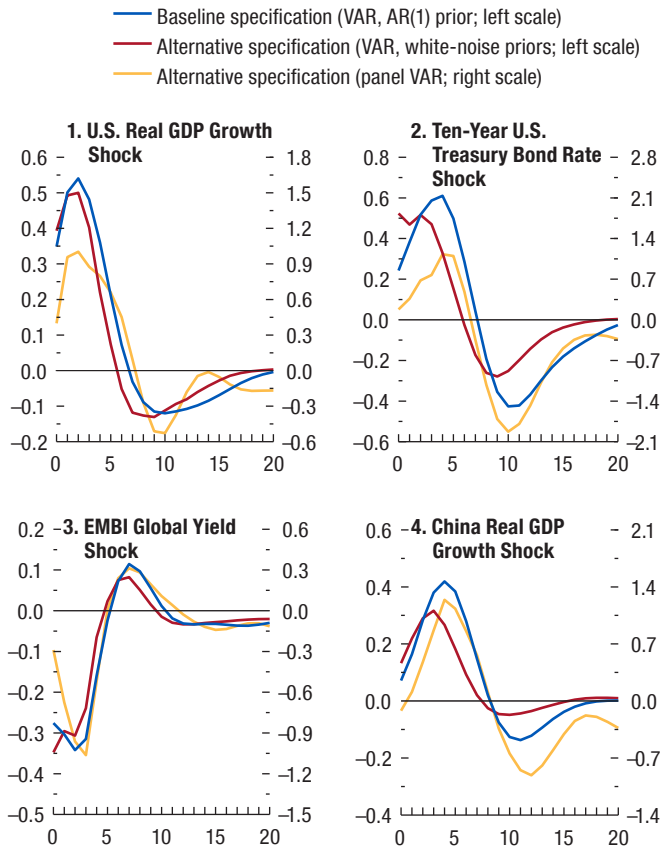


Figure 4.24. Comparison of Impulse Responses from Panel Vector Autoregression with Responses from the Baseline Model
