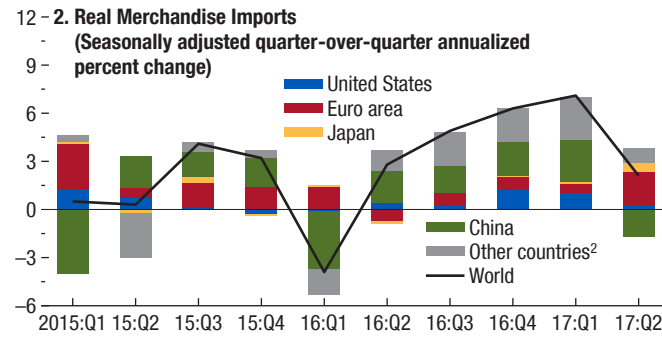
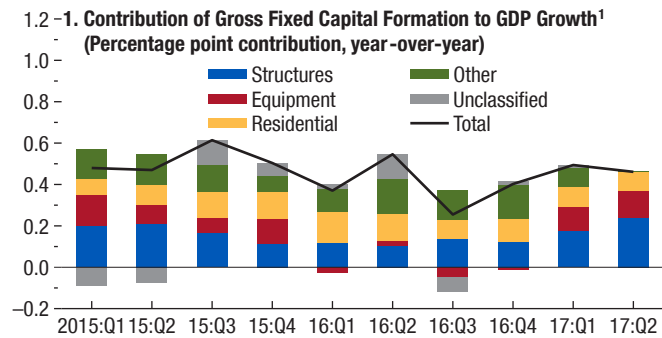


Figure 1.2. Global Fixed Investment and Trade
