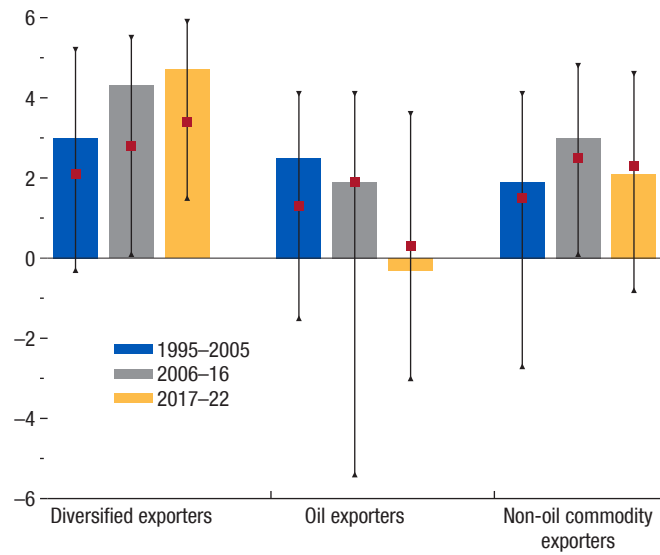


Figure 1.22. Per Capita Real GDP Growth across Low-Income Developing Countries
