<p><i>Holistic Review of BPM6 Update Priorities</i></p>			
9:15–10:45 a.m.	<p>1. Outcomes of the Holistic Review Survey</p> <p><i>In the October 2021 meeting, the Committee endorsed the process for the holistic review of BPM6 update priorities. Following this, a global survey of compilers and users of external sector statistics was conducted during July–August 2022 seeking their inputs on the BPM6 update recommendations included in the Guidance Notes prepared by the Task Teams.
