



# JOINT IMF-INDONESIA HIGH-LEVEL CONFERENCE INTERNATIONAL TAXATION IN ASIA: ISSUES AND THE WAY FORWARD JAKARTA, INDONESIA—JULY 12–13, 2017

## SESSION I—SPEAKER AND PANELISTS



**Vitor Gaspar**, a Portuguese national, is Director of the Fiscal Affairs Department of the International Monetary Fund. Prior to joining the IMF, he held a variety of senior policy positions in Banco de Portugal, including most recently as Special Adviser. He served as Minister of State and Finance of Portugal during 2011–2013. He was head of the European Commission's Bureau of European Policy Advisers during 2007–2010 and director-general of research at the European Central Bank from 1998 to 2004. Mr. Gaspar holds a Ph.D. and a post-doctoral agregado in Economics from Universidade Nova de Lisboa.



**Sri Mulyani Indrawati** is the Minister of Finance since July 2016. Prior to her current position, she was Managing Director of the World Bank (2010–2016), Minister of Finance (2005–2010), Acting Coordinating Minister for Economics Affairs (2008–2009), and National and Development Planning Minister (2004–2005), and Executive Director of IMF for the South East Asia Voting Group (2002–2004). She has received a number of awards as a leader and as minister of finance, some of which include the 23<sup>rd</sup> world's most influential women from Forbes Magazine in 2008 and 2<sup>nd</sup> most influential women in Indonesia from Globe Asia Magazine in 2007. She was awarded as the best Minister of Finance by Euromoney and best Minister of Finance in Asia by Emerging Market Forum in 2006. She earned her bachelor degree in Economics from University of Indonesia, and obtained her M.Sc. of Policy Economics and her Ph.D. of Economics from University of Illinois, Urbana Champaign.



**Il-Ho Yoo** is the former Deputy Prime Minister and Minister of Strategy and Finance of the Republic of Korea. He is also the former Minister of Land, Infrastructure and Transport, and previously a member of Korea's 18th and 19th National Assembly. Dr. Yoo was the president of the Korea Institute of Public Finance, and a professor for 10 years at the KDI School of Public Policy and Management. He earned his bachelor's degree in economics at Seoul National University, 1981 and Ph.D. in economics at the University of Pennsylvania, 1987.



Datuk Seri Johari Abdul Ghani was appointed Minister of Finance II of Malaysia in June 2016. He holds a Diploma in Accounting and later was bestowed a Fellowship of the Chartered Association of Certified Accountants soon thereafter in 1993. Datuk Johari started his career at an international accounting firm, Peat Marwick & Co. (now known as KPMG) as an auditor. He went on to hold senior positions in several companies listed on the Bursa Malaysia which are involved in various industries in Malaysia.

Datuk Seri Johari is active in various social and community services. He is currently the Chairman of Yayasan Bena Nusa which was established to help to reduce urban poverty and improve education for children from urban poor. Datuk Johari has been active in politics for more than 27 years and has held various positions in political parties. Datuk Seri Johari won a parliamentary seat during the general election in 2013. In 2015, he was appointed as the Deputy Minister of Finance.



Indranee Rajah was appointed as Senior Minister of State for Finance and Law from October 2015. She has co-chaired the Committees on Family Justice and on the formation of the Singapore International Commercial Court with then-Judge of Appeal VK Rajah, the recommendations of which have been accepted and are now in implementation. She is currently co-chairing the committee on Strengthening Singapore as a Restructuring Hub with Judicial Commissioner Mr. Kannan Ramesh. Ms. Rajah has been the Member of Parliament for the Tanjong Pagar Group Representation Constituency (GRC) since 2001. She chaired the Government Parliamentary Committee (GPC) for Law & Home Affairs from 2004 to 2006 and the GPC for Defence and Foreign Affairs from 2006 to mid-2009. She was a Deputy Speaker of Parliament from 2006 to 2011.

Ms. Rajah was educated at Raffles Institution in Singapore, and read law at the National University of Singapore. She was in legal practice as a dispute resolution lawyer which included cross-border commercial disputes and international arbitration, until she left to join the government in 2012.



Wayne Swan was the Treasurer of Australia from December 2007 and Deputy Prime Minister from June 2010 until June 2013. He was elected to Parliament for Brisbane from 1993 to 1996, and from 1998 to the present. Mr. Swan obtained his Bachelor of Arts (Hons) degree from the University of Queensland and lectured in public policy at the Queensland Institute of Technology (now QUT) for 12 years.

During his time in Federal Parliament Mr. Swan has been associated, in particular, with steering the Australian economy through the global financial crisis; reforming the tax and transfer payments system; and labour market participation; climate change; ageing and population policy. Mr. Swan published Postcode: The Splintering of a Nation in 2005 about the distribution of poverty and inequality in Australia.

**Astera Primanto Bhakti** is the Head of Education and Training Agency at the Ministry of Finance, and one of the state revenue experts in the Ministry. He started his career in Directorate General of Taxation in 1993. Prior to his current position, he served as Expert Staff for the Minister of Finance on Revenue Policy Affairs (2015-2017) and Expert Staff for the Minister on Revenue Affairs (2015).
