Tax Hackathon: Let's gather to leverage innovation and collaboration for the Senegalese Tax System!

November 3rd & 4th, 2016 Dakar, Senegal





Congratulations! You have been selected to take part in the first hackathon ever in Dakar, Senegal, gathering 80 people from 21 countries to try to tackle the same issue: bringing more simplicity and transparency to the Senegalese tax system.

You have been chosen because you have been identified as an expert either in innovation, IT, tax operations, or tax policy. This event will allow you to work for two days along with other world-class experts to leverage innovation for the tax administration in Senegal.

INNOVATION

During this hackathon, you will be encouraged to have limitless ideas and to try to find solutions that no one ever thought about before! You will be guided through a process that will help you get rid of any self-censorship you may have.

COLLABORATION

You will also have the chance to team up with people from different horizons: three continents will be represented, with people from national and international institutions, large corporates, startups, etc.

As part of the Emerging Senegal Plan, the Ministry is much involved in the modernization and the simplification of its tax system.

The Fiscal Affairs Department (FAD) has been the world-leading source of fiscal expertise for over 50 years. FAD researches and analyzes fiscal developments around the world; provides policy advice to IMF member countries; and provides timely, practical and tailored technical assistance to countries seeking to modernize their fiscal policies and institutions—both on the revenue and expenditure sides of the budget. In recent years FAD has provided advice and support to over 140 countries, covering all regions and income levels, with a view to building durable fiscal institutions. This includes modernizing tax systems and their administration so that they can finance critical social services and infrastructure.



A hacka-what?

- A hackathon is a two-day event that gathers participants from different areas of expertise in order to build innovative solutions to complex issues. Following a dedicated methodology with three steps, you will be guided to collectively:
 - 1. Identify issues you really care about and their real causes;
 - 2. Invent innovative solutions by sharing your ideas;
 - **3. Prototype** these solutions, focusing on the people that will use them at the end of the day, to make them really useful and sustainable.

Within two days, thanks to this methodology and the power of prototyping, you will be able to design innovative solution that may be directly applicable by the DGID!

80 participants will be split into 10 teams around 3 main topics.

Don't panic, we will give you all the information you need to be able to understand any topic and be able to find innovative ideas to tackle these issues.

Data Management at the DGID

How can data management in the DGID be improved? What treatment should be given to historical taxpayer records that are paper-based? How can the DGID ensure their IT system has a complete and accurate recording of taxpayers' information so it can manage taxpayer accounts efficiently? What management / organizational aspects of this issue need to be addressed to ensure IT resources and data are best used in the organization? Relationship between taxpayers & tax administration

What can be done to improve the taxpayers'/users' experience interacting with the DGID? How can these interactions be simplified, whether referring to large corporations, small entrepreneurs, or individuals? How can services and data best be tailored to a taxpayer's individual needs? Relationship between third parties & the tax administration

Voluntary compliance is highest when tax administrations have third-party information to check the veracity of what taxpayers are reporting. What practical steps can be taken to ensure the systematic sharing of taxpayer-related information between the DGID and other organizations (customs, banks, public service providers...), and the effective use of this data by the DGID, with a view to raising compliance levels?
