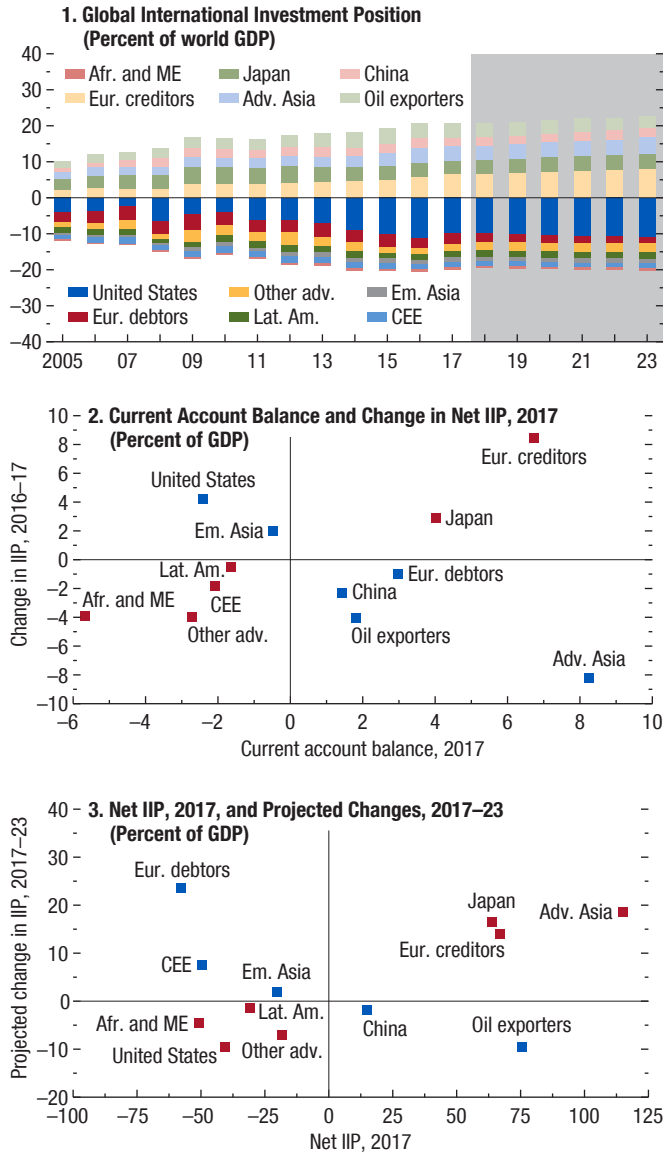


Figure 1.18. Net International Investment Position
